COMMUNICATIONS AND MULTIMEDIA ACT 1998

MINISTERIAL DIRECTION ON INTERWORKING WITH OTHER AUTHORITIES

DIRECTION No. 4 of 2001

In exercise of the powers conferred by sections 7 and 269 of the Communications and Multimedia Act 1998 [Act 588], the Minister issues the following Direction to the Commission:

Citation and commencement

1. This Direction may be cited as the **Ministerial Direction on Interworking with Other Authorities, Direction No. 4 of 2001** and shall come into operation on the date of registration of this Direction.

Interpretation

2. Any term used in this Direction shall unless the context otherwise requires, have the same meaning as in the Act or the regulations made under it.

Interworking With Other Authorities


3. The Commission shall interwork with such authorities and international organizations as are specified in Schedule A of this Direction.

4. In interworking with the authorities and international organizations set out in Schedule A, the Commission may act in its own capacity as regulator of the communications and multimedia industry or on behalf of the Government, as the case may be.

5. Schedule A of this Direction may from time to time be modified, varied or revoked.
